It is to submit that on receipt of reliable information on Date: 01.12.2020, FBO i/c Sadhireddypally accompanied with Forest Range Officer, Kothaguda and Range Staff, rushed to the place of offence i.e., Outskirts of Chandru Thanda fields (Ootai) Village and found 6 persons who committed Wild Life Offence, while hunting the Wild Animal Kanuju (Male) (Cervus Unicolor - Sambar Deer) under Section 9 R/W 2(16), 27, 29, 31, 39, 50, 51 and 57 of Wild Life Protection Act, 1972, which is the Animal in Schedule – III, Sl.No.16. Then a Panchanama was conducted before the two individual Panchas and arrested the accused persons along with the Seizers one (01) Axe and Five (05) Sticks from the scene of office.

Then the injured Kanuju (Male) brought from the spot to the Forest Range Office, Kothaguda for the medical treatment while informing the veterinary Doctor of Kakatiya Mini Zoo Warangal.

It is further submitted that, during the investigation it was conformed that all the alleged accused A1 to A6 are involved in the Wild Life Offence. Reason For The Arrest of the accused:

As per the guidelines issued by the Hon'ble Apex court vide CrI.Appeal No. 1277/2014 between Amesh Kumar Vs. State of Bihar and another and also to satisfy the provisions envisaged U/S.41(1) Cr.P.C. I am submitting the following reasons for causing the arrest of the accused.

1. To Prevent such person from committing any further offences.
2. For proper investigation of the offence.
3. To prevent such person from causing the evidence of the offence to disappear or tempering with such evidence in any manner.
4. To prevent such person from making any incumbent threat or promise to any manner
5. To prevent such person from making any inducement threat or promise to any person acquainted with the facts of the case so as to dissuade from disclosing such facts to the court or to the police officers.
6. As unless person is arrested his presence in the court whenever required cant be ensured.

Hence the above arrested accused Persons A1 to A6 are producing herewith before the Hon'ble Magistrate at Narsampet with a request to remand them to the judicial custody for a period of 14 days to enable us to complete the investigation and enquiry and filing the complaint.


The grounds of arrest have been explained to the accused and also informed to his blood relatives.
