Sir.

With reference to the above cited subject, it is stated that the Board has received a complaint through an email by Ms. Saumya Tandon from Amarpali Sapphire Phase II, Noida Sec-45 about the demand of feeding points near the societies by the animal/dog lovers, such that they could feed animals properly without any hesitation by also considering non-animal friendly residents problems in mind. A copy of the email is attached herewith which is self-explanatory.

- 2. It is stated that the Board vide its letter dated 03.03.2021(Copy enclosed) have issued an advisory to all the Chief Secretarie of the States/Ut's to issue necessary direction all the local authorities to take appropriate step to identify sufficint number of feeding spots for stray dogs in every town, villages, RWA and other institutes and to ensure that he no harssament or hindrance is caused to the person feeding street dog at the deignated feeding spots.
- 3. Also, the Hon'ble Supreme Court had directed to take action against the erring officials as per the Para 77 of the S.L.P.No. (C) 11686 of 2007, Animal

Welfare Board of India Vs A. Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No.30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same is attached herewith for your information.

4. Therefore, it is requested to conduct an physical inspection and identify the feeding spos for street dogs on the above matter and the inspection reports along with your recommendation be forward to the Board.
