The Hon'ble Supreme Court had directed to take action against the erring officials as per the Para 77 of the S.L.P.No.(C) 11686 of 2007, Animal Welfare Board of India Vs A.Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No.30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same are attached herewith for your information.

4. In view of the above, it is requested to constitute a team from the Department of Animal Husbandry, Police Department, and Muncipal Corporation Department to conduct an inspection. It is requested that above inspection may please be conducted on priority basis and the inspection reports along with your recommendation be forward to the Board.
