**Sub: Complaint regarding illegal transportation/trafficking of cattle from Timarpur , North-East District of Delhi to Kashmir for slaughter - Reg**


**Ref: Email dated 31.01.2021 received from Shri Naresh Kadyan**

With reference to the above cited subject, it is stated that the Board has received a complaint through an email by Shri Naresh Kadyan stated that the cattle are being illegally transported in double décor Vehicle (JK 05 E4485, JK05 H1290), animals loaded and suffocated from Delhi to Kashmir for slaughter. It is also stated that the Delhi Traffic Police Officials providing safe passage for gain and profit. This is against the provisions of the Prevention of Cruelty to Animals (Slaughter House) Rules, 2001 Transport of Animals Rules, 1978, (as amended in 2002 and 2009) and violation of the directions of the Hon'ble Supreme Court of India. The Board had issued several advisories and circulars regarding the welfare of animals and the same is available in the website: [www.awbi.in](http://www.awbi.in) . The e-mail is attached which is self explanatory.

The Hon'ble Supreme Court had directed to take action against the erring officials as per the Para 77 of the S.L.P.No.(C) 11686 of 2007, Animal Welfare Board of India Vs A.Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No.30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same is attached herewith for your information.

It is therefore requested to direct the concerned authorities to take appropriate action against erring officials and forwarded the action taken report to the Board within 7 days from the receipt of this letter.
