Sir,

With reference to the aforesaid subject, it is submitted that the Board has received an email from Miss, Tanya Lohia stating that here is a project going on at Dwarka Express Way, Package-1, near Samalka red light, Mahipalpur. At that place I saw so many neilgai wandering around there, and there is no one to take care of them. I am writing this email to give you details of those neilgai that some of them are badly injured. A copy of the compliant is enclosed here with which is self-explanatory.

2 Cruelty against the animals is an offense under Section 3 and 11(1) of the Prevention of Cruelty to Animals Act, 1960, IPC 428 & 429 and violation of the directions of the Hon'ble Supreme Court of India.

3. The Hon'ble Supreme Court had directed to take action against the erring officials as per the Para 77 of the S.L.P.No. (C) 11686 of 2007, Animal Welfare Board of India Vs A. Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No.30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same is attached herewith for your information.

4. In view of the above, it is requested to direct the concerned authorities to investigate the matter and take necessary action against the offenders as per the law. A copy of the action taken report be forwarded to the Board at the earliest.
