Kindly refer to our letter of even number dated 25.08.2015, 28.08.2015 and 14.08.2020 on the above subject.


The Board has received an email from Ayush Garg resident of Rani Bagh, New Delhi stating that his neighbours are stopping him from feeding stray dogs and because of this attitude and continuous harassment from his neighbours, he is not unable to feed the stray dogs. A copy of the complaint is enclosed here with which is self-explanatory.

In this regard, it is brought to your notice that it is a fundamental duty as per Article 51 A(g) of the Constitution of India and it has been brought to the notice of the Board that complaints about animal cruelty and harassment of individuals indulging in ill-treatment of animals are not seriously pursued and action is not taken for filing the FIR by the law enforcement authorities.

The Board has issued advisory requesting Chief Secretaries and Director General of Police of all States/UTs to issue directions to all their police stations and officials to enforce the provisions of The Prevention of Cruelty to Animals Act, 1960 and its Rules effectively and also register the FIRs wherever necessary on a priority basis so that such enforcement becomes a deterrent to the infliction of cruelty on the helpless animals.

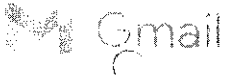
In view of the above, it is requested to ensure the proper enforcement of The Prevention of Cruelty to Animals Act, 1960 and its Rules and to provide justice and protection against the ill-treatment and harassment of the citizen showing compassion towards the animals. Further, it is requested that an inquiry on the above complaint may be initiated and an action report may be forwarded to the Board immediately to take further necessary action.


Respected Sir/Madam
