Sub: Alleged Complaint regarding cruelty against puppy by driving car.

Sir,

With reference to the above cited subject, it has been brought to the knowledge of the Board through an email from Shri Chetan Jhaveri, Surat, Gujarat stated that some person driving a car on the puppy and brock down its back ball permanently, which may made it permanently disabled or turn in to death. A email letter is attached here with which is self explanatory.

Cruelty to animals is an offense under Section 3, Section 11(1) of the Prevention of Cruelty to Animals Act, 1960, and Section 428 & 429 of the IPC.

The Hon'ble Supreme Court had directed to take action against the erring officials as per the Para 77 of the S.L.P. No.(C) 11686 of 2007, Animal Welfare Board of India Vs A.Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No:30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same is attached herewith for your information.

It is therefore requested to direct the concerned authorities to take appropriate action against the offenders as per law. A copy of the action taken report be forwarded to the Board within fifteen days from the receipt of this letter and to take immediate and necessary action to ensure that such cruelty to animals does not take place anywhere or at any time in future.
