**Ref: Email received from Shri. Ashish Yadav.**


Sir,

With reference to the above cited subject, it is stated that the Board has received an email from Shri Ashish Yadav stating that the street dog menace in their region has grievously increased. The Dog bites cases has been severally increased in the area as well as there is constant fear of street dogs in the residents of the area. A copy of the complaint is enclosed here with which is self-explanatory.

The Hon'ble Supreme Court has directed to take action against the erring officials as per the Para 77 of the S.L.P.No.(C) 11686 of 2007, Animal Welfare Board of India Vs A.Nagaraja & Others and the department of Personnel and Training, Ministry of Personnel, Public Grievances and Pension had issued guidelines vide F.No.30/9/2006-Welfare dated 26.5.2006 to take action against such personnel violating the laws. The copies of the same is attached herewith for your information.

In view of the above, it is requested to ensure the proper sterilization the dogs in given area and to strictly implement Animal Birth Control Programmer as per the Animal Birth Control Rules,2001, for the control of the dog population. Further, it is requested that an inquiry on the above complaint may be initiated and an action taken report may be forwarded to the Board immediately to take further necessary action.
