
Kindly refer to Board letter no. 24-1/2019-20/AWB dated 05.03.2020.

With reference to the above-cited subject, it is stated that the Animal Welfare Board of India (AWBI) has received an email dated 01.12.2020 from Ms. Gauri Maulekhi again stressing upon the issue of and irregularities in ABC programme carried out by Bhindi Rishi Pashu Kaylan Samiti, Dakan, Kotda Village, Udaipur without following guidelines of Animal Birth Control(Dogs) Rules,2001. A copy of the complaint is enclosed herewith.

2. In this regard, Udaipur Municipal Corporation was requested to take immediate necessary action in the said matter and ask to submit the report to AWBI vide letter dated 03.12.2019 and 10.12.2019. Further, on receipt of the various complaints against the said organisation, the Board has ordered an inspection vide letter dated 05.03.2020(enclosed).

3. As per rule 6 of the Animal Birth Control (Dog) Rules, 2001 it is responsibility of the Local body to control the population of the stray dog and rabies by implementing the ABC/AR programme. The Animal Birth Control (Dog) Rules,2001 notified by the Government of India directs the local body to constitute a monitoring committee which shall be responsible for the planning or management of the dog control programme in accordance with the Rules. The Board has also issued a circular dated 18.08.2020(enclosed) for proper implementation of the ABC programme.

4. Therefore, in view of the above it is again requested to you to kindly ensure that the ABC programme is implemented as per the provisions of the Rules and guidelines as given in the AWBI module. Also, you are requested to submit detailed inspection report of the Bhindi Rishi Pashu Kaylan Samiti on its ABC programme within 7 days on receipt of this letter for further necessary action
